Current MICS: Please bring any dissemination materials you have already produced. If you have not already produced any dissemination materials, prepare a short document or presentation on your dissemination plans and any dissemination materials you are planning to produce

Further analysis

Bring any further analysis done using previous surveys – any further work or secondary analysis of data which went beyond the final report
